### Course Description:

There is no set of legal issues more bound up with underlying social, cultural, and political currents than health law. A principal aim of the course is to give students an appreciation of how these dynamics have influenced law in the health care context. We will examine such topics as the Affordable Care Act, Medicare, Medicaid, abortion, and pandemics, with readings drawn from court cases and secondary analyses. What forces have coalesced to produce health care legislation, and what is the scope of the rights protected? How has the Supreme Court interpreted the right of Congress to regulate health care? What is the status of abortion rights as the Supreme Court prepares to overrule Roe v. Wade? How have Congress, courts, and administrative agencies interacted to shape not just national health policy programs, but also the government's intervention into pandemics? The course, which lies at the intersection of health politics, law, and policy, will culminate with the crafting of a health policy brief on a topic of the student's choosing, in consultation with the professor.

### Course Requirements:

• 5 page policy memo based on a health policy report of students' choosing: 15%

• 5 page analytic paper: 20%

• 20 page health policy report: 40%

• Attendance and participation in class: 25%
